

## MODIFICATION OF AGREEMENT #1

This modification is made between WHATCOM COMMUNITY COLLEGE (WCC) and the Whatcom Transportation Authority (WTA). On October 27, 2016 WCC and WTA entered into an interagency agreement establishing a program allowing authorized WCC students to have prepaid access to WTA service. The agreement ties eligible student enrollment to the fee paid by WCC for the bus pass program. The program is in effect for four (4) remaining academic years, ending August 31, 2022. WCC and WTA both wish to make the following modifications, to take effect immediately and continue through the remainder of the contract term.

WCC and WTA agree to the following:

1. **MODIFICATION OF EXISTING AGREEMENT:** The Agreement is modified as follows:

For any quarter that a student is registered, their ORCA pass is valid from the first day of the break before the quarter begins until the day after that quarter ends. When a student is registered for consecutive quarters their bus pass will remain valid throughout the intersession.


