

## EXTENSION OF AGREEMENT #2 MODIFICATION OF AGREEMENT #2

This extension is made between WHATCOM TRANSPORTATION AUTHORITY (WTA), a Washington municipal corporation, and WESTERN REFINERY SERVICES, INC., a Washington state registered corporation (CONTRACTOR). On May 3, 2019, CONTRACTOR and WTA entered into a two (2) year agreement for lot sweeping and vactor truck service. The agreement is renewable twice after the initial term in two (2) year increments for a total contract equal to six (6) years.

CONTRACTOR and WTA agree to the following:

1. **RENEWAL OF EXISTING AGREEMENT:** The Agreement shall be renewed for two (2) years effective May 1, 2023 through April 30, 2025. This will be the final renewal allowed under the contract.
2. **PREVALING WAGE:** Pursuant to RCW 39.12.040, CONTRACTOR will file a new intent to pay prevailing wage with Washington State Labor & Industries for the new contract term. WTA will pay prevailing wage rates as of May 1, 2023.
3. **TERMS AND CONDITIONS OF EXISTING AGREEMENT REMAIN THE SAME:** CONTRACTOR and WTA agree the terms and conditions of the original Agreement and any executed modifications remain in effect except for the items noted.
4. **CONTRACT PRICE:** WTA and CONTRACTOR agree to the following price increases for the renewal term:
