


## INTERGOVERNMENTAL COOPERATIVE PURCHASING AGREEMENT


Pursuant to Chapter 39.34 RCW and to other provisions of the law, the Whatcom Transportation Authority, hereinafter called "the WTA" and Ben Franklin Transit hereby agree to cooperative governmental purchasing upon the following terms and conditions:

1. The WTA and Ben Franklin Transit, in contracting for the purchase of goods and services, agree to extend said contract to each other to the extent permitted by law, and agreed upon by the parties.
2. Each party accepts responsibility for compliance with any additional or varying laws and regulations governing purchases by or on behalf of the WTA or Ben Franklin Transit in question. A purchase by either party shall be effected by a purchase order from said party, directed to the vendor or other party contracting to furnish goods or services.
3. The WTA and Ben Franklin Transit accept no responsibility for the performance of any of the purchasing contract by the vendor to the other party, and the WTA and Ben Franklin Transit accept no responsibility for payment of the purchase price by the other party.
4. The WTA and Ben Franklin Transit reserve the right to contract independently for the purchase of any goods or services, with or without notice to the other.
5. Both parties reserve the right to exclude the undersigned, or any class containing the undersigned, from any particular purchasing contract, with or without notice.
6. This Agreement shall continue in force until canceled by either party, which cancellation shall be effected with or without notice to the other party.




WHEREAS, THE INTERLOCAL AGREEMENT IS PREPARED and signed by WTA Manager and Legal Counsel.


NOW, THEREFORE, BE IT RESOLVED BY THE BEN FRANKLIN TRANSIT BOARD OF DIRECTORS THAT:
