

**Amendment #2 of the
Contractual Service Agreement SaaS Solution for Transit Route Planning**

Remix Technologies LLC (“**Remix**”) and Whatcom Transportation Authority (WTA) (“**Customer**” and, together with Remix, the “**Parties**”) have entered into that certain agreement titled Contractual Service Agreement SaaS Solution for Transit Route Planning, dated December 20, 2017, and amended by the Consent to Assignment and Extension of Agreement #1 dated October 24, 2022. Upon execution of this Amendment #2 (the “**Amendment #2**”), the Parties agree to modify the Agreement as follows:

1. **Amendment:** The Parties agree to add Remix Blocking services to the Agreement, as detailed below:
2. **Price:** Customer shall pay to Remix \$4,400 USD, as detailed in the table below, in consideration for this amendment of the Agreement, due and payable upon signing.

Marketing Terms	Willingness to work with Remix to develop a case study, ability to use Customer as a reference.
Additional Services	Customer acknowledges that additional services, such as access to Company's (including its affiliates) proprietary technology platform used to establish, monitor, operate and/or manage fixed-route and demand response transit networks, may be added to this Agreement at an additional cost during the Term.

3. **Conflicts, Use of Terms, Governing Law.** Capitalized terms used but not defined herein have the meanings set forth in the Agreement. Except as expressly provided herein, the terms and conditions of the Agreement remain unchanged. This Amendment #1 will be governed by the same law as the Agreement.
