

**FIRST MODIFICATION TO PURCHASE AGREEMENT

WHATCOM TRANSPORTATION AUTHORITY, a Washington Public Transportation Benefit Area (hereinafter “**WTA**”) and Clever Devices Ltd, a New York corporation (hereinafter the “**Consultant**”), in consideration of the mutual covenants herein, agrees as follows:
